Local Governments Can Take Advantage of EE Rebates

Replacing any street lighting with more efficient LED's? These energy efficiency measure likely qualify for rebates from the PJM Interconnection, the regional transmission organization that controls the flow of power in the Mid-Atlantic. Municipalities throughout Virginia have been taking advantage of these rebates for their interior lighting or green buildings and renovations since 2014 but it is only recently that exterior projects offered comparable financial incentives. Claiming the rebates is fairly easy and contact details can be found on the Department of Mines, Minerals and Energy's [Demand Response site](#).
