U.S. Department of Energy Webinar for Evaluators and Utilities Early Replacement Program for Refrigerators

Presentation by: Association of Home Appliance Manufacturers

DOE is hosting a webinar, presented by the Association of Home Appliance Manufacturers (AHAM), for evaluators and utilities to review a rebate program for the early replacement of refrigerators. AHAM's proposal builds on traditional appliance rebate programs undertaken at the state level, but calls for explicitly linking purchase and disposal rebates in order to enhance energy savings and reduce greenhouse gas emissions (GHG), simplify program management, and streamline EM&V efforts.
