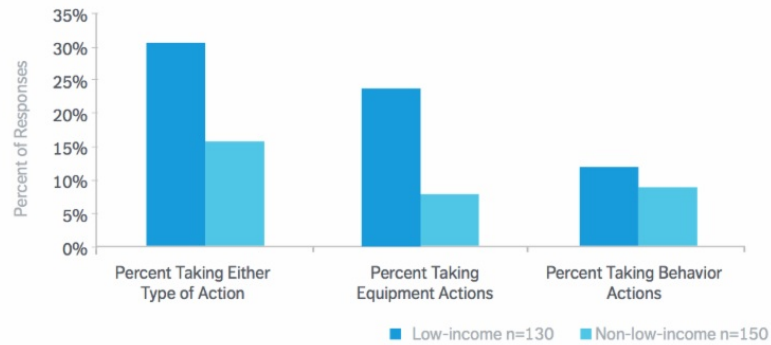

PACE Update

On December 8th, Virginia Community Capital (VCC) held their second and final stakeholder meeting for the PACE Energy Efficiency Loan program at the Trane facility in Ashland. Neal Barber of VCC and Abby Johnson of Abacus Property Solutions presented their findings in front of a varied group of participants including local, state and federal agencies, energy financing, non profits and providers of energy efficiency services. The presentations discussed the interest level of Virginia localities in adopting PACE and recommendations on next steps to ramp up a program in 2016. In break-out sessions after the presentations, participants discussed the pros/cons of a for- and non-profit model for a central PACE program administrator as well as the level of funding required to attain a statewide platform.
