Report from the General Assembly

The General Assembly convened its 2015 session on January 14. This is an odd-numbered year, which in Virginia means an especially brief annual session, so the news will be moving quickly. We're hopeful that there will be several positive developments for energy efficiency. Here's a quick update on the latest happenings:

• PACE Legislation

A VAEEC priority -- Property Assessed Clean Energy (PACE) financing -- is making its way through the legislative

process. PACE is a loan program for property owners to finance energy efficiency and renewable energy measures for their properties. Programs are implemented by localities and the loan is repaid as a special assessment. This has the potential to greatly expand opportunities for property owners and the EE industry, and 30 states have already successfully implemented PACE. Bills have been introduced in both houses (HB 1446 and SB 801) that would enable localities to create these economic development programs for commercial properties. Support is growing, and we'll keep you up-to-date on developments.

Clean Energy Lobby Day

Next week, the halls of the General Assembly will be filled with voices making the case for energy efficiency and clean energy. The VAEEC is proud to be an event partner for the 2015 Clean Energy Lobby Day, scheduled for Tuesday, February 3. More than 90 people have registered for the day, which will include visiting with legislators, networking with fellow leaders in Virginia's energy industry, and several special events.
