Virginia Clean Economy Act GOVERNOR NORTHAM SIGNS THE VCEA INTO LAW

Virginia Clean Economy Act

Last Sunday, Governor Northam signed the Virginia Clean Economy Act into law! This landmark law will pave the way for a carbon-free Virginia by 2045, ensuring investments in energy efficiency, solar, wind, and more. The VCEA mandates 5% energy savings from the investorowned utilities by 2025, with the State Corporation Commission (SCC) determining future savings in three-year blocks. We are excited about the promising future for Virginia.

C-PACE Updates

We're excited to share the new buzz around Commercial Property Assessed Clean Energy, or C-PACE, in the Commonwealth.



New Bill Clears a Path for Future C-PACE Progress

Governor Northam signed HB 654 into law on April 8th, authorizing the Virginia Dept. of Mines, Minerals and Energy (DMME) to sponsor a statewide C-PACE program. This move will make it easier for localities to provide clean energy financing for building owners and their communities. Once launched, localities simply opt-in, using standard ordinance language, program documents, and guidelines. This voluntary program will operate alongside already-established programs in the Cities of Fredericksburg and Petersburg and Arlington, Fairfax,

and Loudoun Counties. "By reducing time, cost and administrative hurdles, Virginia's statewide C-PACE program seeks to provide faster and more equitable access to capital to building owners around the state, particularly in smaller jurisdictions," said Dan Farrell of DMME in a recent statement. C-PACE Lender Resources Now Available

To date, over 200 mortgage lenders across the nation have consented to C-PACE assessments. VAEEC has put together a directory of mortgage lenders who have consented to C-PACE in the Mid-Atlantic region. If you are a property owner, contractor, or developer looking to utilize C-PACE financing, check the directory to see if your mortgage lender is on the list. If they're not listed, the VAEEC and the Mid-Atlantic PACE Alliance have put together a guide highlighting the top six reasons a mortgage lender would consent to a C-PACE assessment. *The Case for Lender Consent: A C-PACE Guide for Mortgage Lenders & Property Owners* is an excellent way to engage your property's senior lender(s) to assess their receptiveness to C-PACE early on in the project. DOE Announces Notice of Intent to Issue Funding to Strengthen Federal Energy and Water Infrastructure



The U.S Department of Energy's Office of Energy Efficiency and Renewable Energy (EERE) intends to issue a funding opportunity to strengthen energy and water infrastructure across federal agencies. Projects will improve the energy efficiency of federal operations while stimulating economic development and creating

jobs in construction, building trades, and other sectors.

Issued on behalf of EERE's Federal Energy Management Program (FEMP), the funding opportunity is entitled "Assisting Federal Facilities with Energy Conservation Technologies (AFFECT) 2020 Federal Agency Call (FAC)." FEMP intends to issue the FAC in spring 2020.
