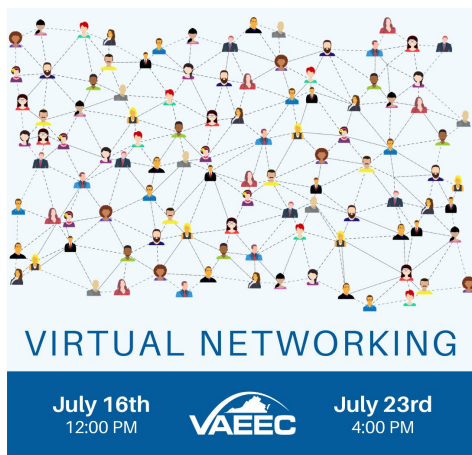
Virginia Clean Economy Act (VCEA). The webinar will be held on **July 22nd at 1:00**.

On June 16, 2020, the hearing examiner in the Dominion Energy DSM Proceeding released his recommendations to the SCC. Overall, the report was positive, recommending that all of the programs be approved- some with modifications- at the budget requested by the company. The VAEEC is drafting comments to address two outstanding issues, but we are pleased with the report as a whole.
